

As of July 1<sup>st</sup> 2012 Virginia has passed a new law which impact owners and tenants. Utility companies are no longer allowed an unlimited time to file liens against properties for unpaid utility bills and are limited to 30 days from cancelation. Most utility companies now require signed authorization from the owner and the tenant so **please make sure you allow enough time to order your utilities.**
